The Director, ICMR-National Animal Resource Facility for Biomedical Research, Genome valley, Shamirpet, Hyderabad invites sealed tenders/ quotations on or before **06.01.2021** by **4:00 PM** from **reputed experienced contractors/ agencies in Hyderabad Telangana State** with established experience to carry out the **"Supply of red soil & Cow dung around the Rodent Breeding building (Approx. 17000 Sq.ft)** at the institute campus as detailed below:

1. Red soil around the Rodent Breeding Building : 20 loads (each load 500 feet)
2. Cow dung – 8 tons (8 tractors)

Terms and conditions

1. The sealed cover should be superscripted **Supply of Red soil & Cow dung – 8 tons (8 tractors) around the Rodent Breeding building (Approx. 17000 Sq.ft) by mentioning tender no., date & due date.** The quote should be **Lumpsum** for carryout out the complete work.
2. Water/ Electricity will be provided by ICMR-NARFBR Hyderabad to the contractors.

4. The offer/quotation in sealed cover should reach the undersigned on or before **06.01.2021** by **4:00 PM** and hand over in the Dispatch Section. The quotation received thereafter will not be considered. ICMR-NARFBR, Hyderabad is not responsible for any postal delays. In case the quotation is submitted by hand, submit on all working days i.e Monday to Friday except public holidays between 11:00AM to 4:00 PM.
5. The Director ICMR-NARFBR Hyderabad has the right to accept or reject any quotation(s) without assigning any reasons.
6. The award of purchase order is subject to the lowest quotation submitted by the firm.
7. Quotation by email or fax will not be accepted.

8. The work shall be completed within 7 days from the date of award of the work.
9. ICMR-NARFBR, Hyderabad is not responsible for payment of wages to the manpower while supplying the Red Soil & Cow dung at ICMR-NARFBR. Further, no transportation charges will be borne by the Institute.
10. Bills submitted by the contractor will be settled after certification by the end user of ICMR-NARFBR with regard to its quality. Any defect in the work has to be rectified free of cost by the contractor within a week from the date of completion of the work.
