The Tender shall submitted in two cover system duly signed by the authorized representative of the bidder as follows.

- 2. The agency/firm/vendor who has quoted the lowest price for a given item will be selected for that product. In case of more than one agency quoting the same lowest price for a product the Institute reserves the right to place order with the agency who has quoted lowest for maximum number of items.

#### Validity of Tender:

#### Award of contract:

- 1. A panel of bidders / suppliers shall be selected for rate contract.
- 2. The Rate Contract will be valid for a minimum period of ONE YEAR, which could be extended for further one more year after satisfactory performance of the firm/company on mutual consent on the rates and terms and conditions. During the contract period No revised rates will be entertained.

- 4. The Director, ICMR-NARFBR reserves the right to enter in to parallel Rate Contract for similar items during the period of Rate Contract with one or more parties.

#### **Delivery Schedule:**

1. Delivery within a period of 10 days of receipt of the Purchase Order either directly or through dealer. (No deviation will be accepted in this regard). Earlier delivery by the supplier is preferred. If the ordered material is not supplied in the above mentioned period, then the Director, ICMR-NARFBR reserves the right to cancel the order/not accept the ordered materials.

- 2 If the supplier fails to deliver the material within the delivery period as specified, the Director, ICMR-NARFBR may procure goods or services similar to those undelivered up on such terms and in such manner as it deems appropriate from any other firm and the supplier will be liable to the purchase for any excess cost. The supplier will be liable to the ICMR-NARFBR for any excess costs incurred for procurement of goods or services not delivered in time.
- 3. The items, so supplied will have to be of high quality and grade and in the inspection / test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the Rate Contract of the firm may be cancelled. #### Liquidated Damages:

- 2. Materials should be delivered within two weeks of the order at Store Department of ICMR- NARFBR, Genome Valley, Shamirpet, Hyderabad-500101.
- 3. Delivery should made within a period of 15 days of receipt of the Purchase Order either directly or through dealer. (No deviation will be accepted in this regard). Earlier delivery by the supplier is preferred. If the ordered material is not supplied in the above mentioned period, then the ICMR-NARFBR reserves the right to cancel the order/not accepts the ordered materials
- 4. If the supplier fails to deliver the material within the delivery period as specified, ICMR-NARFBR may procure goods or services similar to those undelivered upon such terms and in such manner as it deems appropriate from any other firm and the supplier will be liable to the purchase for any excess cost. The supplier will be liable to the ICMR-NARFBR for any excess costs incurred for procurement of goods or services not delivered in time.
- 5. The date of delivery should be strictly adhered to; otherwise the ICMR-NARFBR reserves the right not to accept the delivery in part or full. The liquidated damages @0.5% per week subject to a maximum of 5% of the value of the order can be imposed.
- 6. On receiving the goods at site, the purchaser, through Indenting Officer, with reference to supply order, will verify the quality and quantity of the items supplied. The paying authority will release the full payment to the supplier within 30 working days, after the receipt of supplier's invoice, purchaser's receipt certificate and other accompanying documents like supply order etc. Payment will be released by ICMR-NARFBR through PFMS.
- 7. Price will not be increased during the rate contract period. However on the basis of exigency the same will be considered by the Director.
- 8. The Director, ICMR-NARFBR, Hyderabad reserves the right to enter into parallel Rate Contract for similar items during the period of Rate Contract with one or more parties.
- 9. The contract agreement does not indicate surety of the purchases, on receipt of demands from scientists regarding brand, product, make etc, and the firm will be communicated accordingly.
- 10. The items, so supplied will have to be of high quality and grade and in the inspection/test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the rate contract of the firm may be cancelled.
- 11. Delayed supply/non-compliance of complete order may also lead to cancellation of contract. ICMR-NARFBR, Hyderabad reserves the right to cancel the order/not accepts the ordered materials.

The material is being offered should be indicated clearly whether indigenous manufactured by local registered firm or whether material manufactured by cottage and small scale industries/ large scale industries or partly manufactured in India from imported materials. Any offer to supply on forward delivery basis under supplier's own quota/license will also be considered.
- 14. The rates of GST should be clearly indicated wherever chargeable. The freight, insurance charges if any will not be borne by the ICMR-NARFBR, Hyderabad. Similarly, shortage pilferage in transit will be sole responsibility of the supplier and the same will be intimated to the supplier on receipt of goods by the purchaser to make good the loss caused on this account.
