3	Bananas Ripened but not over ripened bananas each not less than 100gm in weight.	250 Dozen
4	Cucumber (Kakdi / Kheera) Should be of high grade, fresh, tender and clean.	150Kgs

In case the quotation is submitted by hand, submit on all working days i.e. Monday to Friday except public holidays between 11.00 AM to 3.00 PM.
