1	<b>Lucerne Grass</b> Fresh, tender, juicy with green leaves and free from extraneous material and small insects.	2,100Kgs
2	<b>Carrots :</b> Quality No.1, fresh, tender, clean and without mud.	150Kgs
3	<b>Bananas</b> Ripened but not over ripened bananas each not less than 100gm in weight.	250 Dozen
4	<b>Cucumber (Kakdi / Kheera)</b> Should be of high grade, fresh, tender and clean.	150Kgs
5	<b>Fruits Seasonal</b> Fresh, clean, ripened, large size and free from insects, dust and mud. Includes Mango, Guava (Peru), Apple, Grapes, Sapota (Cheeku), Ber, Orange, Blackberry, Jamun.	150Kgs
