If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM\_No.1\_4\_2021\_PPD\_dated\_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. # LFA PRINTER

2. LFA printer (Easy Ab printing device)

1. The LIA printer is required for the symmetrical print of the antibodies on the surface of the lateral flow m embrane in less time and with precision

2. The printer should be able to dispense the reagents uniformly resulting in good line quality.

3. It should be able to print two lines simultaneously over the membrane with maximum printing length of 30 cms.

4. It should have auto reverse facility to make the operation automatic.

5. There should be a provision of variable speed control in the system for controlled dispensing of reagents

6. The pressure on the membrane should be adjustable by a screw in the tip holder

7. Maximum antibody holding capacity of the tank should be  $500\mu l$  so that printing of at least 15 laminates can be done before refilling

8. There should be a provision of total recovery of unused reagents

9. One-year Warranty against manufacturing defect should be provided.

10. Earlier supply record of the strip cutter in the government institution should be attached.

- 11. Training for operating the instrument be provided by the vendor.
- 12. Power 240V, 50Hz.

#### SPECIFICATION OF STRIP CUTTER

1. Programmable strip cutter is required to cut the cards/membranes into strips of desired dimensions, faci litating the customization of strip sizes for the Lateral Flow Assay

2. The cutting speed should be 5000 cuts per hour.

3. The blades should be easily replaceable and are made of hardened alloy steel. In normal operation, I mil lion cuts can be made without the need for sharpening

4. The number of strips that are cut should be programmable and can be varied as per requirement from 1 to 9999.

5. The width of the strips should be programmable from 2mm to 12mm.

6. The machine should be able to cut laminate of width upto 12 cm

7. System should have provision of keyboard entry for strip width definition.

8. Should have emergency STOP switch.

9. One year warranty against manufacturing defect should be provided.

10. Earlier supply record of the strip cutter in the government institutions should be attached.

11. Training for operating the instrument should be provided by the vendor
