4. The offer/quotation in sealed cover should reach the undersigned on or before 16.05.2022 by 03.00 PM. The quotations received thereafter will not be considered. ICMR-NARFBR, Hyderabad is not responsible for any postal delays. In case the quotation is submitted by hand, submit on all working days i.e. Monday to Friday except public holidays between 11.00 AM to 3.00 PM.
5. The Director, ICMR-NARFBR, Hyderabad has the right to accept or reject any quotation (s) without assigning any reasons.
6. The Director, ICMR-NARFBR, Hyderabad has the right to increase or decrease the quantity of plants to be supplied.
7. The award of order is subject to the lowest quotation submitted by the firm.
8. Quotation by email or fax will not be accepted.
9. The supply and work shall be completed within 3 days from the date of award of the work.

10. ICMR-NARFBR, Hyderabad is not responsible for payment of wages to the manpower while supply and planting of plants. Further, no loading & unloading and transportation charges will be borne by the Institute.
11. Bills submitted by the supplier will be settled after certification by the end user of ICMR-NARFBR with regard to its quality/quantity. Any damage/decay in the supply of plants has to be replaced at free of cost by the supplier within a week from the date of completion of the work.
