Terms and conditions

- 1. The sealed cover should be superscripted as "Supply of Red Soil, Dry Cow Dung, Paspalum Grass, and plants" separately mentioning tender No., date & due date.
- 2. The rate should be inclusive of transportation, Labour charge for loading, unloading and planting in the above mentioned area and GST.
- 3. The tenders/quotations should be addressed to "The Director, ICMR-National Animal Resource Facility for Biomedical Research, Genome Valley, Shamirpet, Hyderabad".
- 4. The offer/quotation should be sent in sealed cover by post only so as to reach the undersigned on or before 26.12.2022 by 03.00 PM. The quotations received thereafter will not be considered. ICMR-NARFBR, Hyderabad is not responsible for any postal delays.
- 5. The Director, ICMR-NARFBR, Hyderabad has the right to accept or reject any quotation (s) without assigning any reasons.
- 6. The quotation shall be deemed valid for at least 90 days or such periods as may be specified from the date of opening.
- 7. Rejected supply of above materials shall be replaced at free of cost within 15 days after receipt of intimation from this office.
- 8. The Director, ICMR-NARFBR, Hyderabad has the right to increase or decrease the quantity to be supplied.
- 9. The award of order is subject to the lowest quotation submitted by the firm.
- 10. Quotation by email or fax will not be accepted.

- 11. The supply and work shall be completed within 7 days from the date of award of the work.
- 12. ICMR-NARFBR, Hyderabad is not responsible for payment of wages to the manpower while supply and planting of plants. Further, no loading & unloading and transportation charges will be borne by the Institute.
- 13. Bills submitted by the supplier will be settled after certification by the end user of ICMR-NARFBR with regard to its quality/quantity. Any damage/decay in the supply of plants has to be replaced at free of cost by the supplier within a week from the date of completion of the work.
- 14. ICMR-NARFBR, Hyderabad is not responsible for payment of wages to the manpower engaged by the contractor and statutory dues for the work at ICMR-NARFBR.
- 15. The supplier should supply the red soil as per the sample provided by ICMR-NARFBR, Hyderabad.
