- 1. 1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

End User Certificate: Wherever Bidders are insisting for End User Certificate from the Buyer, same shall be provided in Buyer's standard format only.

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

7. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

8. Generic

- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

11. Turnover

15. Warranty

16. Warranty

- 1. Tender Inviting Authority: This tender enquiry for procurement of 1 Unit of CT Scan is being invited by th e Director General, Indian Council of Medical Research, Ansari Nagar, New Delhi to be supplied at ICMR-Na tional Animal Resource Facility for Biomedical Research, Hyderabad
- 2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids/request for proposals document, they will be suspended for the period of 1 year for bids/request for proposals document from being eligible to submit Bids/Proposals for contracts with ICMR.
- 3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.
- 4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.
- 5. ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the DG, ICMR will be binding and final on the su bject.
- 6. Inspections and Tests: ICMR or its representative shall have the right to inspect and/or to test th e Goods to confirm their conformity to the Contract specifications. Further, The Supplier may have an independent quality test conducted and the cost of such tests will be borne by the Supplier. 7. Packing:

The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extre me temperatures, salt, and precipitation during transit and open storage. Packing case size and w eights shall take into consideration, where appropriate, the remoteness of the Goods, final destina tion and the absence of heavy handling facilities at all points in transit

- 9. Settlement of Disputes:
- (a) If any dispute or difference of any kind whatsoever shall arise between the Procurement agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- (b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such m utual consultation, then either the Procurement agency or the Supplier may give notice to the othe r party of its intention to commence arbitration, as hereinafter provided, as to the matter in disput e, and no arbitration in respect of this matter may be commenced unless such notice is given.
- (c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract. In the case of a dispute or d ifference arising between the Purchaser/Consignee and a domestic Supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sol e arbitrator appointed by Director General ICMR.
- (d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follows.
- (i) The venue of Arbitration shall be the place from where the contract is issued and the language of the arbitration proceedings and that of all councils and communications between the parties shall be English.
- (ii) The decision of the majority of arbitrators shall be final and binding upon parties.

- (a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the enti re stores contracted for arrival in good condition at destination. The transit risk in this respect shall be covered by the Supplier by getting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee.
- (b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the i nsurance will be got extended by the supplier at their cost till the successful installation, testing, c ommissioning and handing over of the goods to the consignee. If the supplier fails to deliver any or all of the goods or fails to perform the services within the t ime frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to othe r rights and remedies available to the purchaser/consignee under the contract, deduct from the co ntract price, as liquidity damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0.5 % per week of delay or part thereof until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reached purchaser may consider termination of t he contract. Since the Liquidated damages are in virtue of non-performance of services, it will attr act GST or any other applicable taxes which in turn shall be deducted from the Supplier.

- 14. Delivery of Equipment means Supply, Installation, Testing and Commissioning of Equipment.

- 17. The manufacturer's authorisation must be insisted upon on a tender specific basis, not general authorisation/ dealership, by so declaring in the bid documents clearly. In cases where the manufa cturer has submitted the bid, the bids of its authorized dealer will not be considered. In cases of a gents quoting in offshore procurements, on behalf of their principal manufacturers, one agent can not represent two manufacturers or quote on their behalf in a particular tender enquiry. One man ufacturer can also authorise only one agent/dealer.
