## **TERMS & CONDITIONS**

The supply will be carried out as per Institute requirements/specifications.

### **Certificates and other approved documents must be submitted:**

1. Vendor must have valid CCSEA registration certificate.
2. Authorization letter from Gram Panchayat or Municipal Corporation after receipt of Purchase Order to catch hold the Monkeys.
3. Health monitoring report (fecal sample analysis and blood sampling reports) at the time of delivery.
4. Tuberculin Skin Test reports and Quarantine records – animals must be quarantined prior to the delivery.
5. Animal observation records - General physical examination and behaviour observation records and clinical signs record (morbidity and mortality record) after receipt of Purchase Order.
6. Records related to date of catching, origin/source location and method of catching.
7. Husbandry conditions - housing, feeding and watering.
8. Veterinarian certificate & clinical examination record from a registered veterinarian
9. Treatment records, if any after receipt of Purchase Order
10. Transportation permit after receipt of Purchase Order.

### **Additional documents to be submitted:**

The Tender shall be submitted duly signed by the authorized representative of the bidder and must be submitted within the period of bid submission:

The following are required duly signed documents:

- Detailed document of required Specifications of Animals.
- Bank details. (Bank details of principal supplier in case of Import shipments)
- Please ensure submission of copies of Purchase Orders executed for similar items to various Govt. Departments / Research Institutes etc.
- Tender acceptance letter.
- Bidder's must have a valid GST Registration Number and PAN and must submit documentary proof of PAN and GST Registration or declaration for non availability of GST may be submitted.
- Income Tax Return filed, Acknowledgement for last 3 years may be submitted.
- Other document mentioned in tender document (if any)

### **Delivery:**

1. There will be a delivery/supply period of 6 weeks in the Purchase Order for all macaques. Vendors may also be required to supply on staggered basis as per the requirement of the Indentor/user department. Delivery of macaques must be with the Health Certificates.
2. The indentor concerned will be the contact point for confirming the date for scattered delivery.

### **Payment:**

- Payment will be made against scattered supplies on each occasion upon acceptance and request by the user department. After successful delivery of the animals, payment will be made by ICMR-NARFBR by PFMS transfer to the bank account.
- In case of multiple batches, the bill for transportation to be submitted with the final bill.
- All the applicable taxes shall be deducted from the bill.
- The price quoted should be inclusive of all taxes/charges including GST and nothing extra is to be paid.

**Cancellation of tender:** Notwithstanding anything specified in this tender document The Director ICMR-NARFBR in his sole discretion unconditionally or without having to assign any reason.
