## **GENERAL TERMS & CONDITIONS**

**Nature of items:** Supply of Electrical items as per specifications.

### **Documents to be submitted:**

The Tender shall be submitted duly signed by the authorized representative of the bidder and must be submitted within the period of bid submission:

The following are required duly signed documents:

- Technical Compliance sheet or brochures (if any).
- Bank details. (Bank details of principal supplier in case of Import shipments)
- Past experience
- Certificate for Tender.
- Self declaration
- Terms & Condition Acceptance Certificate
- Income Tax Return filed, Acknowledgement for the financial years 2021-22, 2022-23 & 2023-24 should be submitted.
- Bidder's must have a valid GST Registration Number and PAN and must submit documentary proof of PAN and GST Registration or declaration for non availability of GST may be submitted.
- Other document mentioned in tender document (if any)

### **Eligibility criteria:**

1. Experience Certificate for the supply of the same to any Government Organizations has to be submitted (if any).
2. Validity to qualify the firm is subject to submission of proper product catalogue with full details (like: Make/ Model/ Pictorial views etc. of the product/item).
3. The bidder has to sign in the required documents one by one as indicated in the Tender document.

### **Supply & Installation:**

- Delivery within 30days from the date of receipt of Purchase Order.
- The items so supplied will have to be of high quality and grade and in the inspection / test if these are found to be of inferior quality the same are to be replaced by supplier at their cost within the stipulated period failing which the order may be cancelled. Delayed supply/non-compliance of complete order may also lead to cancellation of Contract.
- The date of delivery should be strictly adhered to; otherwise the Director ICMR-NARFBR reserves the right not to accept the delivery in part or full.

**Liquidated Damages (LD)** - LD @ 0.5% of the Total Purchase order Value, per week will be levied on the vendor for delay in Supply from the Original delivery date given in the Purchase Order, subject to maximum LD of 10%, beyond which the Purchase Order may be cancelled in to without any financial liability on the Part of ICMR-NARFBR, Hyderabad. The LD so levied will be recovered from the Final Bill Invoice of the vendor. For calculation of the LD, any fraction of the week (i.e. less than Seven Days) will be considered as a week. However, Director, ICMR-NARFBR, Hyderabad reserves the right to waive-off full or a part of the LD so levied, on application by the vendor giving full reasons for delay, and acceptance of such reasons for delay by the Director, ICMR-NARFBR, Hyderabad.

**Payment:**

- After successful supply of the items, payment will be made by ICMR-NARFBR by PFMS transfer to the bank account.
- 100% payment shall be made only after supply of the items in good condition along with successful delivery of items and satisfactory report received by Competent Authority.
- **No advance payment will be made for the supplies.** No Bill for part payment will normally be entertained.

**Warranty:** The items should be provided with min 3 year warranty.

Institute reserves the right to ask the bidders to submit any other supportive documents / clarifications if any require.

**Cancellation of tender:** Not withstanding anything specified in this tender document The Director ICMR-NARFBR in his sole discretion unconditionally or without having to assign any reason.
